WAJAX INCOME FUND ANNOUNCES ITS OCTOBER DISTRIBUTION

Mississauga, Ontario – Tuesday, October 11, 2005 - Wajax Income Fund (“Wajax” or the “Fund”) announced today that its Trustees have approved a cash distribution of \$0.1833 per unit for the period from October 1, 2005 to October 31, 2005, payable on November 21, 2005 to unitholders of record at the close of business on October 31, 2005.

Wajax has three core distribution businesses engaged in the sale and after-sales parts and service support of mobile equipment, power systems and industrial components, through a network of nearly 100 branches across Canada. Its customer base spans natural resources, construction, transportation, manufacturing, industrial processing and utilities. The Fund is an open-ended, limited purpose trust that indirectly owns substantially all of the assets and business formerly conducted by Wajax Limited. The Fund’s units are listed on the Toronto Stock Exchange under the symbol “WJX.UN”.
